



SB #23/24-21: Miscellaneous Amendments to the Governing Bylaws of SUUSA

Parliamentarian/Senate Assistant note:

- 1) A 3/4ths vote is required for passage as stipulated by Article VII of the *Judiciary and Judicial Protocols***

Be it enacted by the SUUSA Student Senate assembled:

1. *Section 1:* The purpose of this bill is to empower the head of the SUUSA Judicial Branch, or their designee (a member of the Judicial Council), to make amendments to the various governing documents for:
 - a. The purpose of resolving grammatical, spelling, punctuation, and clerical errors;
 - b. Reorganizing and making other non-substantive changes to the various governing documents of SUUSA to ensure uniformity of said documents.
2. *Section 2:* The Senate finds:
 - a. That it would be in the best interest of SUUSA and its governance to afford the above powers and responsibilities to the head of the SUUSA Judicial Branch, or their designee;
 - b. That such provisions would save both the Judicial Council and the

Student Senate time in drafting, discussing, debating, and passing legislation in every event an error as described in this legislation is found.

3. *Section 3: Action 1: Section 8, of Article V of the *Judiciary and Judicial Protocol* shall be enacted to read:*

 - a. SECTION 8: The head of the SUUSA Judicial Branch, or their designee, shall:
 - b. A. Be entrusted with the responsibility of resolving and amending any grammatical, spelling, punctuation, and clerical errors in the various governing documents of SUUSA:
 - c. B. Be entrusted with the responsibility of reorganizing the various governing documents of SUUSA to ensure uniformity of said documents such that said reorganizations shall be non-substantive in nature.
 - d. C. Keep a record of resolving or amending any of the errors or organizational/non-substantive changes as described above for inspection upon requests made in good faith by any of the members of SUUSA described in Article I, Section 1 of the Governing Bylaws of the Southern Utah University Student Association.

4. *Section 4: Action 2: The Judicial Vice President shall update and publish the above documents as soon as practicably possible.*
5. *Section 4: Action 3: A member of the Judicial Council shall briefly present all changes to the Senate during the first Senate meeting of each month.*
6. *Section 5: This legislation shall take effect immediately.*
